TOURNAMENT SPARRING & KATA RULES

Competitor will be paired with a student nearest their own rank, size and ability.

**(Safety Equipment Required-NO EXCEPTIONS—HEAD(W FACE MASK) HANDS,FEET, MOUTH PIECES,
(CHEST PROTECTORS ARE OPTIONAL -BUT RECOMMENDED)**

Matches will be determined by the best 2 out of 3 one minute rounds
(3 POINTS MAX—WINNER 2 OUT OF 3 ROUNDS)

light facial contact Allowed—Judges will control level of contact

Point fighting - (best 2 out of 3 rounds)(3 POINTS MAX PER ROUND)

SPARRING POINTS WILL BE : PUNCH 1 POINT/KICK -2 POINTS/NO TAKE DOWNS

*****Continuous sparring-one 2 minute round(light control contact)**

***** WINNER WILL BE DETERMINED BY AFFECTIVE FIGHTER-(3 JUDGES)**
